Approval of Meeting Minutes:

Debbie Beasley motioned to approve October 5, 2022 Regular Board Meeting Minutes. Kenneth Hyde seconded the motion.

Debbie Beasley motioned to approve October 5, 2022 Closed Session Meeting Minutes. Kenneth Hyde seconded the motion.

Town of Lake Santeetlah Interlocal Government Agreement – Water line location services:

The Town of Robbinsville Board discussed changes to the agreement with Town of Lake Santeetlah Mayor Connie Gross. Debbie Beasley motioned to approve the agreement with the following changes: Article II section 2.01 — date change to November 2, 2022
